Call to Order

Chairman Brantley Price called the meeting to order.

Approval of November 17, 2021 Minutes

Brantley Price asked for motion for approval of the November 17, 2021 minutes. Motion was made by Ken Noland and seconded by Phillip Barrier. Motion carried and minutes approved.

NCDOT Traffic Safety Presentation

Brian Murphy, PE, NCDOT Safety Planning Engineer presented a slideshow via Zoom of high level traffic safety trends in North Carolina versus the High Country RPO region. Mr. Murphy reviewed charts and other safety data resources.

Infrastructure Investment and Jobs Act Presentation

David Wasserman, PE, STIP Western Region Manager presented a slideshow via Zoom overviewing the Infrastructure Investment and Jobs Act (IIJA). Mr. Wasserman noted that through the IIJA there will be at least \$410 million in new funding each year for the next five years for highways, bridges, and transit.

State Transportation Improvement Program (STIP) Update

David Graham explained that there is a lot of uncertainty with the upcoming 2024-2033 STIP and how it will be put together. NCDOT is continuing the process in determining how projects will be scheduled in response to rising construction costs. It is likely that committed projects in the current STIP will be scheduled in the 2024-2033 STIP to show the region's priorities. These projects will be eligible for future prioritization cycles. NCDOT Board of Transportation met earlier this month and came to the consensus for the department to proceed with the 2024-2033 STIP by following traditional methods and schedule funding for projects that were previously committed under prioritization cycles 3,4, and 5 until they run out of money. More information to come on this. NCDOT will provide MPOs and RPOs with associated education, training, and coordination with development of the 2024-2033 STIP.

Project Development Update

David Graham went over regional project updates and added that this is now a former committed projects list. At this point, we do not know which projects will survive and make it into the next STIP. More information is coming. David pointed out that the bridge project on 105 in Watauga County has started. This project will benefit the region when complete.

Public Transit Updates

Shelia Blalock and Debbie Smith discussed how public transit agencies are suffering with limited staff since the COVID-19 pandemic. They also noted that an in-person conference and training for NC Public Transit organizations is coming up as well as the Regional Rodeo on June 10th.

Division Engineers' Report

Sean Sizemore gave updates for Division 11 and Chris Guffey gave updates for Division 13.

Transportation Planning Division Update

Pam Cook went over the NCDOT TPD Newsletter which covered several items including no Traffic Forecasts at this time, NCDOT Snow Clearing Policy, and Litter Sweeps.

Committee Member Comments/Other Business

Brantley Price wished Wesley Barker good luck as he is leaving his position in Ashe County for a new job in Carrboro, NC. Members from Avery County discussed an alternate route to Boone during construction hours on the 105 Bridge Project. Charles Hardin mentioned that the sidewalk project from downtown Blowing Rock to Bass Lake is complete and there will be a ribbon cutting on March 8th.

Re: 2024-2033 Draft State Transportation Improvement Program (STIP) Materials

The Draft 2024-2033 STIP was released by NCDOT on April 25, 2022. In an effort to simplify the project information for RTCC & RTAC review, I have included the **May 2022 Project Update** document and the **2024-2033 Draft State Transportation Improvement Program** document that shows projects that have remained committed (scheduled for delivery) from the 2020-2029 STIP **highlighted in green** and projects that are no longer committed **highlighted in yellow**.

Other projects listed on the 2024-2033 Draft STIP that are not highlighted are those projects that were not previously committed in the 2020-2029 STIP, under construction, or are projects outside of the RPO project prioritization process (bridge projects, public transit administration, safety projects, etc.).

As a component of developing the 2024-2033 Draft STIP, NCDOT is allowing for the opportunity to swap eligible projects for other projects if the swap is agreed to by the NCDOT Division and the RPO and the cost of the project swapped in is less than 110% of the cost of the project being swapped out. I have included the **2024-2033 Draft State Transportation Improvement Program: Projects Eligible for Swaps** document that shows eligible committed (scheduled for delivery) projects **highlighted in blue** and eligible unfunded projects **highlighted in orange**.
