Call to Order

Chairman Brantley Price called the meeting to order.

Approval of February 16, 2022 Minutes

Brantley Price asked for motion for approval of the February 16, 2022 minutes. Motion was made by Phillip Barrier and seconded by David Jackson. Motion carried and minutes approved.

Approval of FY 22-23 RPO Planning Work Program

David Graham, Transportation Planner gave an overview of the FY 22-23 RPO Planning Work Program. Brantley Price asked for motion for approval of the FY 22-23 RPO Planning Work Program. Motion was made by Rachel Deal and seconded by Phillip Barrier. Motion carried and FY 22-23 RPO Planning Work Program approved.

NC Clean Transportation Plan Presentation

Jennifer Weiss, NCDOT Senior Advisor for Climate Change Policy presented a slideshow overviewing the NC Clean Transportation Plan. Mrs. Weiss noted that transportation is the number one source of greenhouse gas emissions. Mrs. Weiss discussed the Governor's new executive order and the planning/steps to present the NC Clean Transportation Plan to him by April 2023.

NCDOT Complete Streets Policy Presentation

Alexius Farris, NCDOT IMD presented a slideshow via Zoom overviewing the NCDOT Complete Streets Policy. Ms. Farris discussed the evolution, challenges, and new implementation process of this policy.

Draft 2024-2033 State Transportation Improvement Program (STIP) Update

David Graham explained that the NCDOT has completed the process of how projects are scheduled for the draft STIP, without funding new projects due to recent cost challenges. NCDOT Board of Transportation is going to proceed with the 2024-2033 STIP for Prioritization cycle 6.0. Mr. Graham explained the process and steps. This STIP is still subject to change. Mr. Graham noted that a lot of the High Country RPO project survived this reprogramming.

Public Transit Updates

Shelia Blalock announced that the Public Transit Regional Rodeo will be held on June 10, 2022 in Madison County. Shelia Blalock and Debbie Smith presented David Graham with a Transit Advocate Award from the North Carolina Public Transportation Association (NCPTA) and applauded his support of Transit Authorities in the High Country region.

Division Engineers' Report

Sean Sizemore gave updates for Division 11 and Stephan Sparks gave updates for Division 13.

Transportation Planning Division Update

Pam Cook went over the NCDOT TPD Newsletter which covered several items including no Traffic Forecasts at this time, a link to the Clean Transportation Plan survey, and a recent railroad grant received in Wilkes County for improvements to the Yadkin Valley Railroad.

David Jackson announced that Vision NWNC presented by the Boone Area Chamber will take place on May 19, 2022.

Re: Revised Draft 2024-2033 State Transportation Improvement Program (STIP)

On August 4, 2022 the NCDOT STIP Unit Staff released the revised Draft 2024-2033 STIP which is based on the latest revenue forecast and incorporates additional revenue from the state’s sales tax. To simplify the project information for RTCC & RTAC review, I have included the **August 2022 Project Update** document that shows projects that are scheduled for delivery in the Draft 2024-2033 STIP.

As a component of developing the Draft 2024-2033 STIP, NCDOT is allowing for the opportunity to swap eligible projects for other projects if the swap is agreed to by the NCDOT Division and the RPO and the cost of the project swapped in is less than 110% of the cost of the project being swapped out. Due to the revised Draft STIP release, the project swap deadline has been extended from October 28, 2022 to March 17, 2023.

I have included the revised **Draft 2024-2033 State Transportation Improvement Program: Projects Eligible for Swaps** document that shows projects scheduled for delivery **highlighted in blue** and eligible unfunded projects **highlighted in orange**.
