The Rural Transportation Advisory Committee held their quarterly meeting, August 16, 2023, at 2pm in the High Country Council of Governments Board Room. The following members were present:

Call to Order

Chairman Woodie Young read the Ethics Statement and called the meeting to order. Chairman Young recognized and welcomed new members in attendance.

Approval of May 17, 2023 Minutes

Woodie Young asked for a motion for approval of the May 17, 2023 minutes. Motion was made by Todd McNeill and seconded by Mike Inscore. Motion carried and approved.

Opening of Public Hearing for Amended FY 23-24 RPO Planning Work Program

Mike Inscore made a motion to open the public hearing for the Amended FY 23-24 Planning Work Program. Todd McNeill seconded the motion. Motion carried.

Closing of Public Hearing for Amended FY 23-24 RPO Planning Work Program

With there being no business or comments for the public hearing, John Irwin made a motion to close the public hearing for the Amended FY 23-24 Planning Work Program. Stoney Greene seconded the motion. Motion carried.

Approval of Amended FY 23-24 RPO Planning Work Program

David Graham, Transportation Planner gave an overview of the amendment of the FY 23-24 RPO Planning Work Program budget, which is an increase in funding of \$23,937.00 bringing the new total to \$183,500.00. Wayne Bonomo made a motion to approve the Amended FY 23-24 RPO Planning Work Program. John Irwin seconded the motion. Motion carried.

Approval of Prioritization 7.0 New Projects List

David Graham, Transportation Planner discussed the Prioritization 7.0 New Projects List and thanked the managers for their help compiling the list. Mr. Graham noted that there are 24 highway projects, 9 bicycle/pedestrian projects, 1 transportation planning project, and 8 aviation projects in the list. Mr. Graham explained that at the RTCC meeting this morning, John Yates, Wilkes County manager asked to swap one of their projects. Stoney Greene made a motion to approve the Prioritization 7.0 New Projects List, including the swap in Wilkes County. Mike Inscore seconded the motion. Motion carried. Meagan Phillips recused herself from voting due to potential conflict of interest concern.

Regional Transit Plan Pilot Study Presentation

Bryan Lopez, Regional Planning Manager for the Integrated Mobility Division of NCDOT presented a slideshow via Zoom overviewing the Regional Transit Plan Pilot Study which will include multi-modal planning initiatives. Mr. Lopez will be coordinating a Regional Transit Plan Guidebook project with the High Country area stakeholders that kicked off 2 months ago. This guidebook will be for 2025-2029. Mary Kate Morookian with Kimley-Horn is leading the High Country Transit Plan Initiative.

Carbon Reduction Program Presentation

Mark Eatman, Statewide Initiatives Engineer for the Transportation Planning Division of NCDOT presented a slideshow via Zoom overviewing the Carbon Reduction Program. Mr. Eatman explained that this program began in 2022 and the main goal is to reduce CO2 emissions through transportation projects. Mr. Eatman reviewed project guidelines and details and noted that the program accepts applications continuously.

Prioritization 7.0 and 2024-2033 STIP Project Development Update

David Graham, Transportation Planner noted that the submittal online portal is now live and that he will be working with managers on data review and scoring of projects October-March. In May 2024 counties will be able to prioritize their projects. Mr. Graham noted that the NCDOT Board of Transportation approved the 2024-2033 STIP and reviewed projects that will begin construction soon.

Division Engineers' Report

Michael Poe, Brendan Spencer, and Samuel Henson gave updates for Division 11 and McCray Coates gave updates for Division 13.

Transportation Planning Division Update

James Upchurch, Engineering Manager introduced Reuben Crummy, the new TPD Coordinator. Mr. Crummy gave a brief overview of the TPD Newsletter including Ashe Count CTP work, an IMD quarterly update, and much more.

Committee Member Comments/Other Business

Committee members asked questions to NCDOT officials and thanked them for all they do.

There were no public comments.



American Emergency Vehicles Facility – Ashe County

Description: Widen roadway and install signal at NC 88 and Northwest Drive.

Description: Construct right turn lane from US 19E northbound to NC 194 eastbound.
